

Release and Waiver of Liability Xposure Youth Foundation, Inc.

Please Read Carefully! This is a Legal Document That Affects Your Legal Rights!

This Release and Waiver of Liability executed on this _____ day of _____, 20____, by _____ a minor child ("Volunteer") and _____, the parent having legal custody and/or the legal guardian of the Volunteer (the Guardian), in favor of Xposure Youth Foundation, Inc. and nonprofit officers, employees, agents, and corporate partners (collectively, "Xposure").

The Volunteer and Guardian desire that the Volunteer work as a volunteer for Xposure and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities may include running, lifting, and interacting with youth and seniors.

The Volunteer and Guardian hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver. Volunteer and Guardian does hereby release and forever discharge and hold harmless Xposure and its successors, contractors, and corporate partners and assigns from any and all liability, claims, and demands of whatever kind or nature, either law or in equity, which arise or may hereafter arise from Volunteer's Activities with Xposure.

Volunteer and Guardian understands that this Release discharges Xposure from any liability or claim that the Volunteer may have against Xposure with respect to any bodily injury, illness, death, or property damage that may result from Volunteer's Activities with Xposure, whether caused by negligence of Xposure or its officers, directors, employees, or agents or otherwise. Volunteer also understands that Xposure does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment. Volunteer and Guardian does hereby release and forever discharge Xposure from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Xposure.

Assumption of Risk. The Volunteer and Guardian understands that the Activities included work that may be hazardous to the Volunteer, including, but not limited to, loading and unloading, and transportation to and from the work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Xposure from all liability for injury, illness, death, or property damage resulting from Activities.

Insurance. The Volunteer and Guardian understand that all Xposure Volunteers are not covered by any liability insurance policy. Xposure does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage for all Activities.

Photographic Release. Volunteer and Guardian does hereby grant and convey unto Xposure all right, title, and interest in any and all photographic images and video or audio recordings made by Xposure during the Volunteer's Activities with Xposure, including but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other. Volunteer and Guardian expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Georgia, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Georgia. Volunteer and Guardian agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
